1. The Budhinanda Municipality invites sealed quotations for works/goods listed in the table below.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Budhinanda Municipality, Nepal or may visit PPMO website: [www.bolpatra.gov.np](http://www.bolpatra.gov.np)
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements. (Only for BM/PTB/SQ/07/077/078)
4. Bidders should download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp.np](http://www.bolpatra.gov.np/egp.np). Bidders, should submit their bid electronically only, and should deposit the cost of non-refundable amount listed in table for bid in the following details:

5. Sealed bids must be submitted to the office of the Budhinanda Municipality through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on April 19, 2021 (Chaitra 06, 2077). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on April 19, 2021 (Chaitra 06, 2077) at the office of Budhinanda Municipality, Bajura. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
9. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
