4. Pre-bid meeting shall be held at Budhinanda Municipality, Bajura at Feb 17, 2021 (Falgun 5, 2077) at 13:00 hrs.
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00** on March 05, 2021 (Falgun 21, 2077). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on March. 05, 2021 (Falgun 21, 2077) at the office of Budhinanda Municipality, Bajura. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
9. All other issued shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement works Regulation 2064 including latest amendment.
10. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
